COVID-19 RESTRICTION EXEMPTION PROGRAM (REP)

Alberta has declared a state of public health emergency. COVID-19 cases and hospitalizations continue to rise, largely in unvaccinated Albertans. New measures to protect the health care system, stop the spread, and increase vaccination rates came into effect starting September 16, 2021.

The City of Calgary made the REP into a By-Law on Sep 23, 2021 which means the following actions need to be taken by the renters of the facility:

Face masks are required while indoors, refer to Alberta Health - CMOH Order 45-2021.

Individuals who have COVID-19 symptoms are not allowed to be on the premises.

All attendees of functions must be screened for one of the following at the point of entry:

- Proof of vaccination – QR Code on the patron's COVID-19 Immunization Record must be scanned for validity; or
- Proof of a negative privately paid test result from a sample that is taken within the prior 72 hours (Results from Alberta Health Services are not eligible and rapid on-site testing is not allowed), or
- An original (non-copied) medical exemption letter.

Individuals 12 years or older must produce valid personal identification

Individuals who are under the age of 12 are exempt.

The name and the date of birth of the individual listed on the proof of immunization or testing must be matched with the name and date of birth on the identification (for ages 12+).

Employees, contractors, repair workers, delivery workers, volunteers, inspectors or others who are entering the event for work purposes and not as patrons are not required to be screened.

IMPLEMENTATION

This document is a part of the Rental Agreement, all attendees of the function must adhere to the above rules.

The renter is responsible to see that the REP requirements are enforced including scanning the QR code on the patron's Immunization Record.

- The renter will be required to have a device to scan the codes. The app is free and is found on the [Google Play Store](#) or the [Apple App Store](#)
- Patrons who do not have a QR code can quickly get their records online here: [Alberta Covid Records](#) or can receive a printed copy free of charge from any Alberta Registries office.
- Per the City of Calgary By-Law it is mandatory to verify the QR code against a valid piece of government ID for those 12 and over.

If the renter does not follow these rules, the security deposit could possibly be forfeited.

A checklist is provided (under separate cover) and upon entry to the function a designated person will record the names of all attendee's and place a checkmark that they have shown valid ID and valid QR scan to prove that they have either been vaccinated, tested or are medically exempt.

A copy of the completed checklist to be given to the SAPF Rental Agent.

To protect people's privacy no copies of the person's documents and / or ID will be made or recorded.

This policy will be in effect until such time the Alberta Government rescinds the order.
